


Gently used clothing is greatly appreciated the ladies can earn points doing chores at the shelter to shop in the Rachel's Boutique.


LEGISLATIVE UPDATE

Last month, Governor Arnold Schwarzenegger endorsed Assembly Bill 1844, “Chelsea’s Law,” which provided a significant boost to this bill as it maneuvers through the legislature. “It is our job to make sure that we have the right laws in place that will keep our children safe,” the governor said in a recent statement.

This legislation was inspired by Chelsea King’s family and emphasizes locking up the most violent offenders for life. It would increase penalties for sexual predators, including adding a one-strike provision for the worst crimes that would put an attacker behind bars for life without parole. Assemblyman Nathan Fletcher, Governor Schwarzenegger, and Moe Du-bois, the father of Amber, are seeking to pass this legislation as a way to help authorities respond quickly when children are snatched off the streets.

Chelsea’s father, Brent King, stated that “Chelsea was fascinated with leadership issues and wanted to get involved in bringing about positive change. She most certainly is involved here today. She’s behind this movement to protect our children from violent sexual predators.”

During my recent trip to Sacramento meeting with our legislators on health care reform, it was heart-warming, and sobering, to see Chelsea’s Law posters on all of the San Diego area representatives doors. Within the bill, May 25th, 2010, is proposed as the National Missing Children’s Day in order to heighten the awareness and find ways to help prevent future crimes, such as these.


